# *Prevent Funding for Antisemitism*

## **Mandate Antisemitism Training at Higher Education Institutions**

- Implement mandated training and require reporting on measures to combat rampant antisemitism
- Prohibit State funding to institutions failing to comply

## **Real Consequences for Student Hatred**

- Prohibit the granting of tuition assistance to students knowingly engaging in antisemitic activities

## **Stop Support for Administrators that Encourage Antisemitism**

- Ensure no taxpayer money is granted to colleges or universities authorizing, facilitating, or funding any event promoting antisemitism on campus



# *Address Violent Pro-Hamas Protests*

Calls for violence against our Jewish neighbors across New York State  
must be addressed



Prosecute threats of mass harm as hate crimes and make them bail eligible



Require an arrest where there is reasonable cause to believe a hate crime has been committed



Reinstate penalties for loitering while masked with a group of six or more persons



Establish the crime of deceptive wearing of a mask during a protest





# *Support Our Allies*



*GIVE NEW YORK'S FULL SUPPORT FOR ISRAEL*

**Oppose the “Boycott, Divest, Sanction” (BDS) Movement that is built on ignorance**

Prohibit State contracting with, and State investment in, companies or people promoting or engaging in activities boycotting American allies



**Prevent New York support for Hamas and nations funding terror**

Enact the “Not on Our Dollar” plan that prevents non-profits from supporting Hamas or terrorist-supporting nations and allows for civil penalties/private right of action for violations

## ENDING ANTISEMITISM RELATED LEGISLATION





## Prevent Funding Antisemitism

- **“Dismantling Student Antisemitism (DSA) Act”**: Implements mandated training, requires reporting on antisemitic incidents and prohibits state funding to institutions failing to comply ([A.2376](#), [Ra](#)).
- **“Stop Antisemitism on College Campuses Act”**: Prohibits funding to higher education institutions allowing antisemitism on campus ([A.4797](#), [A. Brown](#)).
- **“Combating Campus Antisemitism Act”**: Prohibits the granting of tuition assistance to students knowingly engaging in antisemitic activities ([A.4772](#), [A. Brown](#)).

## Address Violent Pro-Hamas Protests

- **Bail Eligibility/Hate Crime Expansion**: Restore judicial discretion when determining pre-trial release by making threats of mass harm bail eligible and allowing them to be prosecuted as hate crimes. Makes specified harassment and menacing crimes bail eligible when charged as hate crimes ([A.9127](#), [Barclay](#)).





## Address Violent Pro-Hamas Protests (continued)

- Loitering While Masked or Disguised: Provides a person is guilty of loitering when being masked while congregating in a public place with six or more persons (A.4773, A. Brown).
- Requiring Hate Crime Arrests: Requires an arrest when a police officer has reasonable cause to believe a hate crime has been committed (A.4766, A. Brown).
- Deceptive Mask Wearing: Establishes the crimes of deceptive wearing of a mask and aggravated deceptive wearing of a mask during public protests, rallies, and assemblies (A.3826, Reilly).
- Defining Antisemitism: Requires the State Education Department to define antisemitism as defined by the International Holocaust Remembrance Alliance in 2016 for the purposes of violations of the Civil Rights Act of 1964 (A.4758-A, Slater).





# Assembly Minority Ending Antisemitism Legislation

## Support Our Allies

- **"Not on Our Dollar!: Ending New York Funding of Hamas Violence Act"**: Prohibits not-for-profit corporations from engaging in unauthorized support of Hamas and nations known to fund middle-eastern terrorist group activity while allowing for recovery of a civil penalty by the State Attorney General and creates a private right of action for violations (A.5214, Novakhov).
- **State Contracts and Investment Ban**: Prohibits state contracting with, and state investment in, persons and businesses that promote or engage in activities to boycott American allies such as Israel (A.4761, A. Brown).
